BLI	Baseline Interference - Cannabinoid peak interference in chromatographic baseline affecting QC recovery .
BLK	Analyte detected in method blank, but not associated samples.
BSH	Blank Spike High - Blank Spike recovery above method limit. no detections in samples.
BSL	Blank Spike Low - Blank Spike recovery below lower method limit, analyte chromatography reviewed manually for all samples.
C	Interference due to co-elution
CBD	CBD matrix interference on GC Pest chromatography
